- No Dearness Allowance will be paid to the participants, as per the Lr. F.No. 1-13/2017 (HRDC), dated 04-06-2018, of Shri Jithendra, Education Officer, University Grants Commission, New Delhi. **(Letter enclosed)**

**Accommodation:** Free accommodation will be provided to non-local participants from 2(f)/12(b) Institutions, at University Guest House of JNTUH, Kukatpally, Hyderabad, on twin sharing basis.

The participants need to bare the following charges during the course period.

**Food Charges:**

- 1) For non-local participants Breakfast, Lunch, Dinner, Tea & Snacks may be provided at Rs. 207/- (including GST) per participant per day.
- 2) For local participants Lunch, Tea & Snacks may be provided at Rs. 112/- (including GST) per participant per day.
